SECTION 3: QUALIFYING CRITERIA FOR TECHNICAL BID

1. Tender document fee and tender processing fee and the EMD amount to be deposited online through e-procurement portal (<https://eproc2.bihar.gov.in>) (Supporting document to be uploaded)
2. Eligible entities: The Bidder should be Sole Proprietorship firm OR Partnership firm registered with the Registrar of Firms (RoF), OR Company registered under companies act OR State level Co-operative/Multi-State level Co-operative registered under the respective State Co- operatives Act and Central Co-operative Act respectively. (Copy of Sole Proprietorship/ Partnership deed / Memorandum & Articles of Association/ Copy of By-laws and registration certificate to be uploaded.)
3. The Bidder should have valid seed license issued by competent authority for whole of Bihar and should remain valid till the completion of tender.
4. The Bidder should possess valid (a) Seed Producer Registration Certificate and (b) Own /lease Seed Processing Plant Registration Certificate issued by respective State Seed Certification Agency and both the certificates should remain valid till the completion of tender.
5. Bidder should have valid registration certificate for PAN and TAN and to be uploaded.
6. The Bidder should have experience in dealing with supply of seeds to Government agencies and have successfully executed any work order in the last 03 years for the **period 2022-23, 2023-24 & 2024-25** (Copy of work order issued by concerned govt agencies to be uploaded)
7. Average annual turnover of the bidder from supply of seeds in any of the two years for the period **financial year 2022-23, 2023-24 & 2024-25** should not be less than **Rs.10.00 crores (Rs Ten crores)**. (CA certificate and copy of Audited Balance Sheet of the company to be uploaded as supporting document.)
8. Copies of Income tax return filed for any of the two years for the financial year 2021-22, 2022-23 & 2023-24 to be uploaded.
9. **Certification for Non-Blacklisted:** The bidder or the eligible entity should not have been debarred / blacklisted by any Government (Central & State govt) since **financial year 2022-23** and till the date of closing of tender. (Notarial Affidavit to be submitted as per Annexure-B)

SECTION 5: TERMS & CONDITIONS

5.1 The quotation is to be invited on Two Bid System (Technical Bid and Financial Bid).

5.2 The Technical bid will contain EMD & other relevant documents like seed licence, Income Tax return, Balance sheet, Performance Certificate/work order and all another relevant documents as given in Section 4 of the NIT.

5.3 While quoting the rates the bidder must ensure that rates quoted in all cases must be final & inclusive of all charges/Taxes F.O.R delivery at destination including all packing & insurance charges for safe transit by road inclusive of all taxes, levies etc.

5.4 Selection of successful bidder would be based on Least Cost Method (LCM)

5.5 Rate quoted by bidder must be in figures and words format. No alternations should be made to any of the Terms and Conditions of the quotation by scoring out, altering or over-writing and no alternations are permitted in their rates. Ambiguity must be avoided in filling quotation. The quotations not complying with these conditions will be rejected.

5.6 The financial bid will be opened as per schedule in respect of those bidders only who have been declared qualified in the Technical bid.

5.7 The bidders who are interested to quote the rates only for one or two items are eligible for participation in the quotation and will have to deposit full & fixed amount of EMD notified in the NIT and no exemption or relaxation on this ground will be accepted.

5.8 VALIDITY PERIOD OF TENDER (BID VALIDITY PERIOD)

Tender/offer will be valid for 180 days from the date of opening of the tender. EMD will be forfeited if the tenderer withdraws or alters its bid/offer during the bid validity period.

5.9 EARNEST MONEY/BID SECURITY

- a) Payment of interest free EMD of Rs. 25,00,000.00 (Rupees Twenty Five lakhs) shall be submitted through e-payment gateway challan/ NEFT / RTGS on <https://eproc2.bihar.gov.in>. Tender without EMD will be summarily rejected.
- b) EMD of unsuccessful tenderers will be returned as per e-proc guidelines.
- c) EMD taken from a bidder shall be forfeited in the following cases-
 - i. When the bidder withdraws or modifies its bid after opening of bids;
 - ii. When the bidder does not execute the agreement, if any, after placement of supply/work order within the specified period;
 - iii. When the bidder does not deposits the performance security within the specified period after the supply/work order is placed and;
 - iv. If the bidder breaches any provision of the code of integrity prescribed for bidders specified in Rule 130A of Bihar Financial Rules.

5.10 ACCEPTANCE OF QUOTATIONS

The Corporation is not bound to accept the lowest quotations. Any or all the quotations may be rejected without assigning any reason. It reserves the right to accepting in whole or part of the offer made. The decision of the Corporation in the matter shall be final and binding.

The Corporation may take decision to split the order among two or more than two firms in a transparent manner as per terms and conditions.

5.12 PERFORMANCE SECURITY

The EMD deposited along with the tender by successful bidder may be adjusted against Performance Security and would be released only after 60 days beyond the date of satisfactorily completion of supply as per the supply order.

5.12 EVALUATION/ACCEPTANCE CRITERIA OF BID

- a) Tender will be awarded to the eligible lowest bidder for any item (seed). In the event of quoted price of the eligible lowest bidder not found justified/not found reasonable by tender/purchase committee, negotiation can be held with him (i.e. L-1 party) for reduction in rate. Negotiation should normally be avoided and should be resorted to only in unavoidable /urgent cases when there is urgent need for purchase.
- b) If it is found that the quantity to be procured/purchased is more than what L-1 is capable of supplying, then the balance quantity will be distributed among next higher bidders (L-2, L-3) at the accepted rate of lowest bidder i.e. L-1 to fulfil the requirement.
- c) Conditional offer shall not be accepted by BRBN and the tenderer shall not impose any term/condition.
- d) BRBN reserves the right to accept/reject any or all of the tenders without assigning any reason whatsoever.

5.13 PERIOD OF COMPLETION OF SUPPLY

- a) Supply will have to be completed by supplier/successful bidder within the time schedule as fixed in the work order issued to the supplier. Non supply of seeds as per the work order would amount to breach of contract and thus would lead to cancellation of work order and the contract entered into with the supplier and the purchaser shall have the right to complete the supply from other L-2/L-3 bidder.
- b) The supplier will have to supply entire ordered quantity of seeds within the period as mentioned above. However, extension in delivery period/period of completion of supply may be granted by MD, BRBN for a period as may be deemed fit.
- c) If extension in delivery period/period of completion of supply is granted on administrative ground by BRBN, no penalty will be imposed. However, if extension in delivery period/period of completion of supply has to be granted due to failure on part of supplier, the penalty @ 5% per week of the cost of quantities supplied in the extended period may be imposed as per the discretion of the Managing Director.

5.14 SPECIFICATIONS OF SEEDS AND THEIR TESTING:

- a) The seed stock shall conform to the quality specifications prescribed in the Minimum Seed Certification Standard, 1988 as amended up to date and shall possess good physical appearance and lustre.
- b) The tenderer shall make available a copy of the source of seed used in seed chain to produce the certified/Hybrid seeds supplied to BRBN.
- c) On receipt of seed in the godown of dealer/distributor, sample will be collected by concerned Seed Inspector/ District Agriculture Officer (DAO) or any other competent authority as per "Seeds Act" for germination test/seed analysis. Minimum one sample should be taken from each lot of seeds supplied in a district.
- d) No any objection will be raised by the supplier for the collection of sample by concerned Seed Inspector /DAO for germination test/seed analysis as per seeds act or as may be required. Further, any quantity of seeds used for the purpose of collection of samples by any of the concerned authorities would be replenished by the supplier for which they will raise the bills to BRBN quoting as "Used for Sample purpose"
- e) BRBN shall have the right to inspect the operation of packing of seeds at the source of the supplier from time to time.

5.15 PAYMENT TERMS:

- a) The payment claims will be made by supplier after supply of seeds.
- b) The payment will be made on basis of quantity which has been supplied and accepted by BRBN and duly uploaded on BRBN software and the same be approved by the dealers of BRBN respective District Agriculture Officer (DAO)
- c) The rate offered by supplier will be on F.O.R (Freight on Road). The L-1 rate offered by supplier will include 8% Dealer Commission and 3% handling Charge of BRBN. The supplier will be paid only 89% of rate quoted in the tender.
- d) Deduction of Dealers commission @8% and handling charges @ 3% and other statutory deductions will be made from each bill amount whenever payment is made to supplier.
- e) The first 50% payment will be made to the Supplier by BRBN after the total accepted quantity is uploaded on BRBN software and is approved by the concerned Dealer & District Agriculture Officer (DAO).
- f) Balance Payment will be made after the satisfactory germination test report/seed analysis report as per prescribed standard is received and the challan /GR (Goods Receipt) dully signed by Agriculture Co-ordinator /Block Agriculture Officer/District Agriculture Officer (DAO) and concerned Dealer which has to be uploaded in BRBN software, after that the final payment will be paid to supplier.
- g) BRBN will make final balance 50% payment to the supplier upon submission of the source of seed for the quantities supplied to BRBN. Germination/ Seed analysis report from respective Seed Testing Laboratories (STL) and uploaded on BRBN portal is to be

considered before releasing final payment to the supplier. If the seed germination report from districts is not received to BRBN from 03 months from date of supply, the germination of seeds will be presumed to be correct and the payment will be done to supplier.

- h) If germination report of any particular lot supplied in any district is unsatisfactory, with respect to minimum germination percentage prescribed in Seed Act for that particular crop/seed, then such seed of that particular lot to be return to the supplier. In such case, it will be the responsibility of the supplier to take back the seeds at his own cost. However, if the seeds are not returned to the supplier due to the same distributed among farmers for unavoidable reasons, before seed analysis report is received, the payment for entire quantity of the particular lot supplied in the particular district will be made to the supplier at the rate of (A -50) % only of the accepted rate in the contract where "A" is the actual value of normal germination in percentage as obtained in seed analysis test report.
- i) Above mentioned payment procedure may be changed, under special circumstances.
- j) The supplier shall be responsible for GST/ Income Tax liabilities and other taxes as leviable, if any. BRBN will not bear /entertain the tax liability related with the transaction by the tenderer/supplier

5.16 VALIDITY OF RATE AND PERIOD:

The bidder shall keep their rates open for a period of one year from the date of issue of supply order.

5.17 CANCELLATION OF CONTRACT FOR DEFAULT & RECOURSE TO BE TAKEN BY THE PURCHASER:

- a) The purchaser (BRBN) may without prejudice to any other remedy for breach of contract by 07 days written notice of default sent to the supplier terminate the contract in whole or in part.
- b) In the event the purchaser terminates the contract in whole or in part, purchaser may take recourse to any one or more of the following action:
 - i. Recovery of all damage sustained on account of cancellation of contract.
 - ii. Performance security deposit to be forfeited.
 - iii. However, the supplier shall continue to perform the contract to the extent not terminated.

5.18 OTHER TERMS AND CONDITIONS

- a) In case of the short supply of quantity after issue of supply order/award of contract, BRBN reserves the right to take the supply from next higher bidders at accepted rate of lowest bidder. In such cases, penalty @ 5% will be imposed for the short supply amount.

- b) The following will be mentioned in Hindi on all the bags of seeds by the supplier at his/her own cost.

- c) The successful tenderer shall at his cost execute an agreement with BRBN on non-judicial stamp paper of Rs. 1000/- for arranging the supply as per these terms and conditions, signing each page of the terms and condition etc. within one week of issue of work order. All the pages of tender document and supply order will also be part of contract agreement and annexed with the agreement form duly signed
- d) BRBN reserve the right to increase/decrease the final requirement of the quantity as per actual requirement basis. The supplier will have no claim for increase/decrease.
- e) BRBN shall not be responsible for fluctuation in the rate of the ordered seed. The tenderer shall be required to supply the seed at agreed rate only. The agreement can be terminated at any time due to non-performance of any of the terms and conditions of the agreement or cancellation of seed licence or blacklisting of the entity during the period of supply as per the discretion of the corporation.
- f) BRBN will not be responsible for losses incurred to the supplier/tenderer due to change in Govt. Decision, natural calamities, which are beyond the control of BRBN.
- g) The weight of Seed Container/bags may be checked at any point of transaction and in case shortage found in the container/bags, BRBN will not pay any cost against such supplies and the tenderer shall be responsible for the legal consequences of Weights and Measures, Department of Agriculture, Bihar.

5.19 FORCE MAJEURE CLAUSE: If supplies are delayed due to cause beyond the reasonable control of the supplier and whether such delay or impediment occurs before or after the time of delivery, an extension of time shall be granted at the sole discretion of BRBN taking into account all factors like flood, drought, Natural calamities sabotage, Fires, Epidemics, Civil commotion, Wars, Revolutions, lockouts, Strike called by the Labour / Trade Unions, transporters etc. and the purchaser shall not be liable for any loss caused to the supplier on account of Force Majeure and reserve the right to cancel the contract without any obligation to compensate the supplier in any manner for whatsoever reason.

5.20 FRAUD AND CORRUPT PRACTICES:

- a) Any bribe, commission, or advantage offered promised by or on behalf of the Tenderer to any officer of official of the Corporation shall in addition to any criminal liability which the Tenderer may incur) debar his tender from being considered. Canvassing on the part of, or on behalf of the Tenderer will also make his tender liable to rejection.

- b) In case of any clear indication of cartelization, the Corporation shall reject the tender(s), and forfeit the EMD.
 - c) If the information given by the Tenderer/Party in the Tender Document and its Annexure is found to be false/incorrect or has violated/breached any of the terms & conditions of the contract, at any stage, BRBN shall have the right to disqualify/ summarily terminate the contract, forfeit EMD/Security deposit, make good any other losses caused to the Corporation and debar the party for three years, without prejudice to any other rights that the Corporation may have under the Contract and law.

5.21 SETTLEMENT OF DISPUTES AND JURISDICTION OF COURT:

- a) Any difference or dispute out of or in connection with this quotation or acceptance thereof, on the contract entered or consequence thereof, shall be mutually decided by arbitration. The sole arbitrator shall be duly appointed with the mutual consent of both the contracting party and the sole arbitrator's decision shall be final and binding on both the parties.
- b) The parties agree that in the event of any disputes, neither will approach any court of law unless they have resorted to and exhausted the remedy of Arbitration as envisaged above.
- c) The parties, do hereby also agree that the contract envisaged by these terms and conditions shall be deemed to have been entered into at Patna and the civil courts /criminal courts at Patna only will have the jurisdiction to try legal proceeding which may arise out of this contract. Neither party shall file any proceeding in any other courts.
