Corrigendum

Short Notice Inviting Tender no. Marketing -05/2026-27

To whom so ever it may concern

Notice is hereby given that "Short Notice Inviting Tender No. Marketing-05/2026-27" published on e-procurement portal vide **reference no. 138751** and **Press release no. PR-010718 (B & C) 2026-27** has been modified to the effect as given below-

1. The Term & condition clause 4.4 at page no. 8 has been modified and read as-

Clause 4.4 :- " While quoting the rates, the bidder shall ensure the availability of the required quantity of raw seed of the offered crop/variety. The raw seed intake quantity available on the Sathi Portal at the time of submission of the bid shall be considered for determining the available quantity."

2. The Period of completion of supply clause 4.16.1 and clause 4.16.6 at page no. 10 has been modified and read as-

Clause 4.16.1 :- "The supply shall be completed by the supplier/successful bidder within **7 (seven) days** from the date of issuance of the supply order" and

Clause 4.16.6 :- " To ensure timely delivery of seeds to the concerned districts against the Supply Order, transportation of seeds through courier services shall be strictly prohibited. Seed consignments 100 quintals and above shall be transported only through GPS-enabled vehicles, and the supplier shall provide BRBN with the vehicle and driver's details along with live GPS tracking access. For consignments of less than 100 quintals, the supplier shall provide the vehicle registration number, driver's name and contact number before dispatch. Non-compliance with this condition shall attract appropriate action/penalty as decided by Managing Director, BRBN" respectively.

3. The Payment Term clause 4.18.6 at page no. 12 has been modified and read as -

Clause 4.18.6 :- " The balance 50% payment shall be released upon receipt of the Seed Quality and Germination Certificate, duly signed by the DAO and uploaded on the BRBN Portal. If the seed germination report from the concerned district is not received by BRBN within 03 (three) months from the date of supply, the payment shall be released only after documented sampling/testing or upon an officially recorded failure of the concerned testing authority to conduct the testing within the prescribed time. In case of delay in compliance with the above requirements, the balance payment may be released against an Indemnity Bond valid for a period of 180 (one hundred eighty) days from the date of submission of the Indemnity Bond furnished by the supplier, subject to the approval of the Managing Director, BRBN".

All other terms and conditions shall remain unchanged.
