TERMS AND CONDITIONS

1. The Price bids will be scrutinized by the BRBN Purchase Committee.
2. The lowest price for each input offered by Empanelled Manufacturer may be selected by the BRBN purchase committee. Whenever for reasons for Marketability, the Committee of BRBN is of the opinion to negotiate the rate downwards, it may call up lowest rate quoted (L1) bidder and finalize the negotiation.
3. In the interest of work and exigency, BRBN may get the supply of Agriculture Inputs from any Empanelled Manufacturer on Lowest quoted price (L1)/Negotiated price.
4. The Manufacturer can quote the rate for one or all Agriculture Input, but the Manufacturer/Supplier must have valid Manufacturing license of concern State and the Marketing license of Bihar. The rate quoted by the Manufacturer will not be accepted without valid Manufacturing license and Marketing license.
5. The L-1 rate offered by Manufacturer/Supplier will be on F.O.R (Freight on Road) inclusive of all relevant taxes & GST. The rate offered by Manufacturer will include 8% Dealer commission and 3% Handling charge of BRBN and the same will be deducted from admissible payment.
6. The Manufacturer has to strictly follow the packing instructions as well as other instructions given by BRBN. Breach of the instruction will incur financial and other consequences to the selected bidder as decided by BRBN.
7. If the selected bidder sells similar inputs, goods, works or services at a price lower than the rate quoted in price bid anywhere in the State of Bihar or in nearby State at any time during the currency of the Work Contract, the offered price shall be automatically be reduced with effect from the date of reducing or quoting lower price, for all delivery of the inputs/subject matter of procurement/supply under that work contract and the work contract shall be deemed amended accordingly. The bidders shall give an Affidavit to the effect that he will not sell inputs in Bihar or nearby State at lower rate than the same offered in price bid.

8. If any dispute arises out of the work Contract with regard to the interpretation, meaning and breach of the terms of the EOI, the matter shall be referred by the parties to the MD BRBN/ Head of the Department who will appoint his senior most Officer as the Sole Arbitrator of the dispute whose decision shall be final.
9. Legal proceedings, if arises by any of the parties, the same may be lodged in court situated in Patna and not elsewhere.
10. Any cutting on bidding document shall be attested and signed by authorized person of the bidder. Any amendment in document submitted by bidder will not be entertained by BRBN.
11. The Rate offered by the bidder will be finalized by BRBN purchase committee only after the approval from the competent authority i.e. MD BRBN.
